SIERRA BANCORP DECLARES QUARTERLY CASH DIVIDEND

Porterville, CA – July 17, 2009 – Sierra Bancorp (Nasdaq:BSRR), parent of Bank of the Sierra, today announced that its Board of Directors declared a regular quarterly cash dividend of \$0.10 per share, subsequent to the Board’s review of the Company’s preliminary financial results for the second quarter of 2009. The dividend is based on the Company’s achievement of financial results consistent with internal projections, and is the same as paid last quarter on a per-share basis. The dividend will be paid on August 14, 2009 to shareholders of record as of July 31, 2009.

Sierra Bancorp is the holding company for Bank of the Sierra (www.bankofthesierra.com), which is in its 32nd year of operations and is the largest independent bank headquartered in the South San Joaquin Valley. The Company has \$1.3 billion in total assets with 23 branch offices, an agricultural credit center, an SBA center, an online “virtual” branch, and over 400 employees.
